### **OPTIONAL: Day Trip to Ubud & Surrounds *(for Accompanying Persons only)***

Head to Ubud early in the morning to experience a different side of the island of Bali. See the rice padi fields, a beautiful water temple and natural springs decorated with authentic Balinese old-style designs. Afterwards, lunch is included in a restaurant overlooking the beautiful and luscious green valley. You will also get a chance to stroll through the village before returning to the hotel.

**Saturday, 1 December 2018, 14:00 pm – 17:30 pm**

### **OPTIONAL: Visit to the Holy Temple of Pura Uluwatu**

Perched precariously on the southwestern tip of the peninsula atop sheer cliffs, this is one of several important temples to the spirits of the sea along the south coast of Bali. A temple was first established here in the 11<sup>th</sup> century by the Javanese priest, Empu Keturan, and later added to by another Javanese priest, Nirartha, who is known for his other seafront temples on the island (such as Tanah Lot, Rambut Siwi and Pura Sakenan).

As this is a holy site, you will need to dress appropriately.
