How to get there

Barcelona Airport (BCN) is the second largest airport in Spain and has excellent connections with most European cities as well as airports in North and South America and The Middle East.

Barcelona International Airport, just 20 km away from the city, is well connected with to the centre by train and a good motorway connection. We recommend that you take a taxi from the hotel. The airport taxis generally charge about EUR 25-30, and your journey will take approximately 20 minutes.

The R2 train line connects T2 of the airport to Sants Railway Station in Barcelona. From there you may take the Underground line L3 to Paseo de Gracia, walking distance from the hotel.

If you arrive at terminal T1, use the shuttle bus Bustransit T1-T2 to get from one terminal to the other. The bus is free and takes about 10 minutes.
