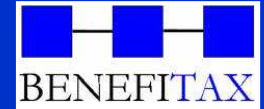

1. IBFB Database starts on 1 July 2012



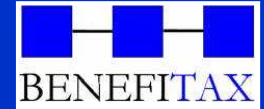
- Licensing of the IBFD tax research platform will start on 1 July 2012.

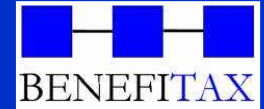

b) If you have a very brief Real Estate announcement (just a few lines) on a new legislation, etc. you also can send it to her.

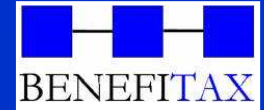

- So far only ITPG member Dr. David Stanek mentioned to me he might go there so ITPG will not offer a seperate meeting there.

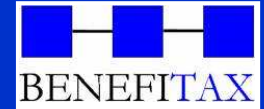

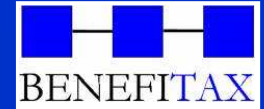
5. Future ITPG Meetings

- Suggestions for presentation of several other short topics (15-20 minutes incl. Q&A)?

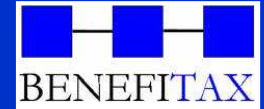
