With Ratefinder you can - with a few clicks - generate one chart covering all rates on all types of payments. This allows you to gain a total overview of one country's tax rates situation in relation to all other countries. Ratefinder - with its user friendly structure - immensely facilitates your database search.

Ratefinder is divided in two different main views: *Per Country* and *Per Payment*.

In *Per Country* you focus on one country's tax rates and figures for all types of payments in relation to all other countries. As an example you may collect all withholding tax rates from

one country in relation to all the other countries in one view. You may also change the view and list all the rates to one country from all the other countries.
