ARRIVAL

The DoubleTree by Hilton Amsterdam Centraal Station hotel is situated in a prime location adjacent to Amsterdam Centraal Station. From the hotel, which overlooks both the historic city centre of Amsterdam as well as the IJ River, the most historical part of the city, the main shopping area and tourist attractions are all within easy range.

Schiphol International Airport

Schiphol International Airport is located only 26.8 km from the DoubleTree by Hilton Hotel Amsterdam Centraal Station and can be reached in approximately 15-25 minutes both by taxi and public transport.

A direct train line runs between the airport and the hotel every 10-15 minutes.

Car

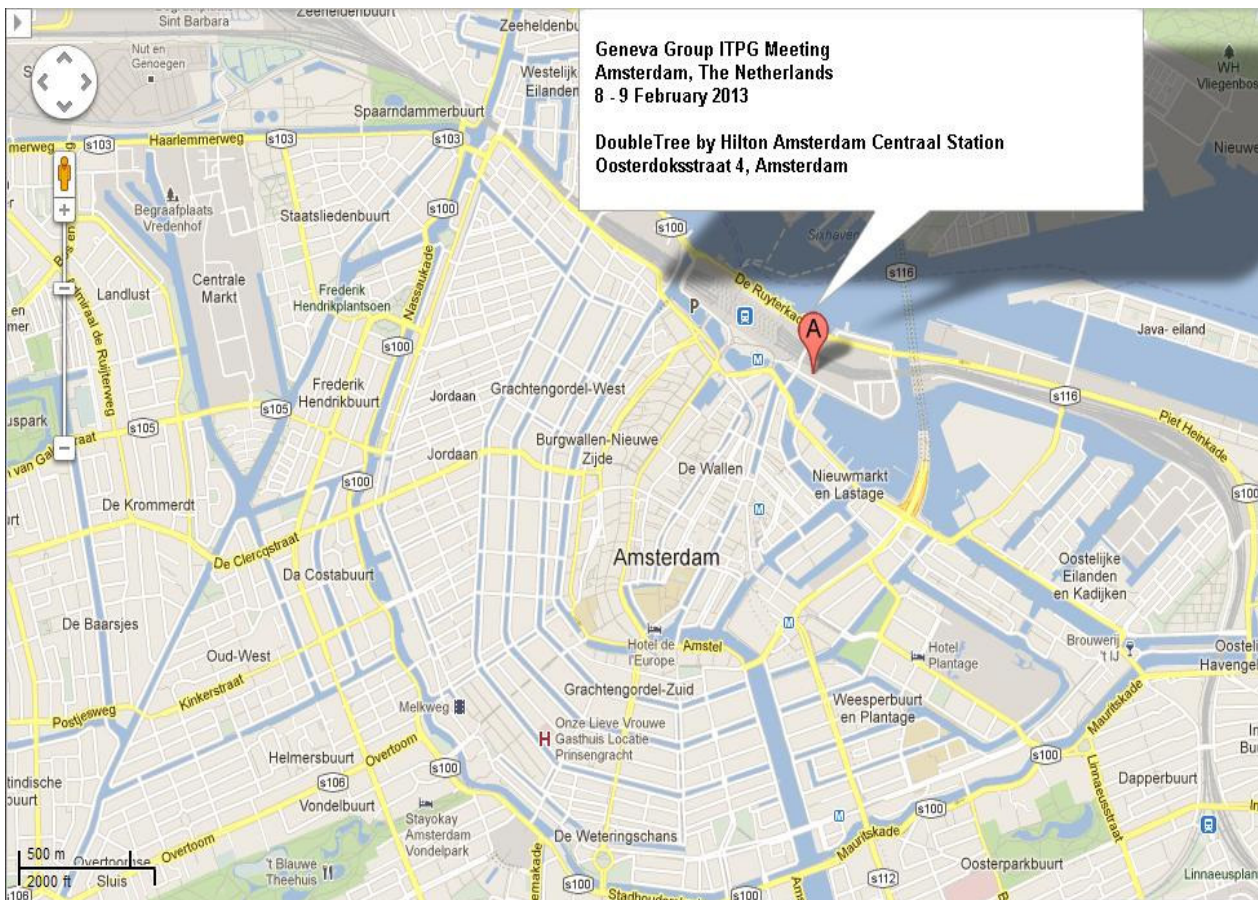
